Lianne Brito, Tara Ippolito, and Paige Massey were selected to receive Boulder AAUW's Brown Ricketts Udick (BRU) Scholarships for 2020-2021. Our three scholarship recipients will share their research and graduate work with Boulder branch members.



Lianne Brito is a first-year PhD student majoring in Geotechnical Engineering. She expects to finish her academic studies in May of 2024. She holds a Bachelor of Science in Civil Engineering and her goal is to use her skills to develop safer highways and higher quality bridges that can have a positive impact on people's daily lives. Lianne was born in Cuba and emigrated as a youngster to the Miami area with her mother.

Tara Ippolito is a PhD Student majoring in Environmental Studies. She expects to complete her degree in April of 2024. Tara is applying her background in mathematics and computer science to study the livelihood outcomes (health, income, well-being) of farming communities in the developing world. She is interested in creating intervention strategies that help improve both the amount of food produced and the livelihood of farmers.





Paige Massey is a first-year PhD student majoring in Philosophy. Her goal is to become a professor of analytic philosophy at a research university. She specializes in identifying conditions for rational belief when constraints on available evidence prevent us from achieving certainty. Paige spent six months at Yad Vashem World Holocaust Center in Jerusalem where she prepared a major international seminar to train educators to more effectively and ethically teach the Holocaust.

AAUW Public Policy Report for January, 2021

Boulder AAUW members have survived an unusual 2020 and we hope you are looking forward to a positive, productive 2021. With a vaccine coming and more changes to in-person contact on the horizon, we have much to anticipate this year. The Inauguration of a new President and installation of Colorado Senator John Hickenlooper and some changes in the U. S. House of Representatives will take place this month. It will be interesting to watch the proceedings of each chamber and see what pertinent legislation comes from the national level.

Closer to home the Colorado Legislature will convene on January 13, 2021. There are several changes in representation due to term limits for districts in which our members live. SD-17 will be represented by Democrat, Sonia Jacquez Lewis, and SD-23 by Republican, Barbara Kirkmeyer. HD-11 by Democrat, Karen McCormick; HD-12, Democrat, Tracey Burnell; HD-13, Democrat, Judith Amabile; HD-49 Republican, Michael Lynch; and HD-63 Republican, Dan Woog.

At this time Capitol room assignments and contact information is not available for the 2021 legislative representatives. That information should be available after the AAUW Colorado Public Policy Day. We will share it on our website and in the newsletter after its publication.

Don't forget to register for AAUW Colorado's Public Policy Day, February 6, 2021. Information about the virtual program and how to register is on page 5 of this newsletter. The legislative agenda as it pertains to AAUW issues will be discussed at this meeting. We will receive information on issues to support, oppose, and/or monitor. Those positions and information on contacting your legislator when asked by AAUW Colorado will also be put on the Boulder website and noted in the newsletter.

Redistricting of Congressional districts and Colorado state senate and representative districts will take place this year. The U. S. Census Bureau will deliver its report to the President on December 31, 2020. The Bureau will release counts to the states by April 1, 2021, and the drafting process will begin after that date. The apportionment by population could change both the congressional and state legislative boundaries for the next ten years as we have seen extensive growth in both metro and rural areas of Colorado.

Boulder AAUW's best line of information on redistricting will come from Boulder County League of Women Voters. Your co-chairs will be in contact with them for the latest information.

If you are not certain you are signed in to National's "Two Minute Activist" you need to do so immediately. Go to www.aauw,org,sign in with **your member number** and **password.** In the **Member Center**, click on **What We Do**, go to Public Policy, click **Two Minute Activist** and register. This will you allow you to receive updated links to access national legislative status information and contact your senators and congressman when requested by AAUW.


Marilyn Leist Needs Your Help

Loveland Sculptor Jane DeDecker Created 'Every Word We Utter' Sculpture

Loveland artist's sculpture becomes a monument to the suffragist movement

With the stroke of a pen, President Donald Trump brought the dream of Loveland residents Jane DeDecker and Jody Shadduck-McNally one step closer to reality. The president signed into law bipartisan legislation authorizing placement in Washington, D.C. of an outdoor monument honoring the women's suffrage movement, the women who over 70 years fought for the right to vote.

DeDecker's sculpture *Every Word We Utter* features Susan B. Anthony, Elizabeth Cady Stanton, Sojourner Truth, Harriot Stanton Blatch, Ida B. Wells and Alice Paul.

"It is fitting to close this year — the centennial of women's suffrage — with this strong declaration for the history and legacy of the women's suffrage movement. Women deserve this commemoration, and the battles for equality that continue today deserve it, too," DeDecker said in a statement.

The bill was sponsored by Rep. Joe Neguse, a Lafayette Democrat, and cosponsored by every member of Colorado's congressional delegation. "The ratification of the 19th Amendment was a historic moment in our nation's history, and the suffragists who fought to secure the right for women to vote are American heroes," Neguse said in a statement. "This statue will honor their perseverance, commitment, and the long-fought victories gained by all women."

No taxpayer dollars will be used in building or maintaining the monument.

(Many of us fondly remember having the opportunity to hear Jane DeDecker speak about her sculpture at a Boulder AAUW meeting.)
